- 8. The classes, or regional or other groups, of members that the corporation is authorized to establish:
  - (a) Class A Members. Class A members shall be entitled to notice of and to attend and vote at meetings of the members of the Corporation and shall be entitled to two hundred votes at all meetings of the members of the Corporation.
  - (b) **Class B Members.** Class B members shall be entitled to notice of and to attend and vote at meetings of the members of the Corporation and shall be entitled to one vote at all meetings of the members of the Corporation.

## 10. Additional provisions

- (a) The Corporation shall be carried on without the purpose of gain for its members, and any profits or accretions to the corporation shall be used in furtherance of its purposes.
- (b) Directors shall serve without remuneration, and no director shall directly or indirectly receive any profit from his or her position as such, provided that a director may be reimbursed for reasonable expenses incurred in performing his or her duties. A director shall not be prohibited from receiving compensation for services provided to the corporation in another capacity.
- (c) The directors may appoint one or more additional directors who shall hold office for a term expiring not later than the close of the next annual meeting of members, but the total number of directors so appointed shall not exceed one-third of the number of directors elected at the previous annual meeting of members.
